## Minute 2019/32: Representatives:

Council **resolved** to appoint the following representatives for the 2019/20 year:

- Cllr Husband to represent Council for matters relating to the Village Green and to continue to represent Council on the St Mary's Church Yard and Church Fabric Fund;
- Cllr Steed to represent Council on matters relating to Transport, with the support of Cllrs Cox and Pryor on matters relating to Airports and to Highways and Railways respectively;
- Cllr Steed, with support from Cllr Husband, to continue to champion the Parish Council entry to Villages in Bloom;
- Cllr Horden to represent Council for matters relating to the Village Pond;
- Cllr Pryor to undertake the weekly Insurance check, to represent Council on matters relating to Surrey Police and, with support from Cllr Bourke, to represent Council on matters relating to Countryside Access (rights of way);
- Cllrs Cox and Jones to jointly champion matters relating to Community Wellbeing;
- Cllr Pryor to represent Council at the SSALC AGM that is due to be held at Dorking Halls on Tuesday 15<sup>th</sup> October 2019. [...]
